- 829 Community Infrastructure Levy (CIL) Funds The RFO reported that no further CIL Payment is due from the Sulis Down development 17/02588/EFUL

830 South Stoke Parish Council resolved to make the Local Council Pay award to increase the Clerk's Hourly rate from £14.95 to £15.58 backdated to 1st April so giving back pay of £198.45, and to increase the Parish Sweeper's Hourly Rate from £11.82 to £12.45 backdated to 1st April giving back pay of £189.00.

# 7. General Parish Matters

- **831** Midford Telephone Box It was reported that the refurbishment of the Telephone Box is complete, and that it awaits collection and installation. This is expected in the next two weeks.
- **832** Request for Defibrillator in Midford Cllr. Mark Knowlton reported that the British Heart Foundation grant application had been turned down. He is seeking alternative avenues for funding the project.
- **833** Midford Parish Council Notice Board The Midford Parish Council noticeboard has been removed because the wall on which it was located has been demolished. The Clerk has not yet re-sited it on the opposite side of the road, on posts, next to the Grit Bin. The Clerk will liaise with Cllr. Mark Knowlton to arrange a suitable time for its re-installation.
- **834** Village Hall The Village Hall Management Committee reported that they had sufficient funds for the Thermal Insulation, and have gone ahead and done this.
- **835** Allotments The Clerk has written to the tenant with the uncultivated plot, at the time of the meeting there had been no reply, but discussions are ongoing.
- **836** Police liaison and Neighbourhood Watch The was a report of a House Break-in and a Break-in to car. Cllr. Jonathan Woodings has met with Sue Dawson and they are looking to re-establish the Beat meetings at the Packhorse. There is a Coffee morning on 3<sup>rd</sup> December. In Midford, a resident is trying to set up a Neighbourhood watch group.
- **837** Churchyard –The necessary repairs to the Southern Wall have been completed. The North Wall is not considered to be at risk of any collapse, but could be considered for repair using the Churchyard Agency Fund balance.
- **838** Website and IT Upgrades Transfer of Domain and e-mails All Councillors have confirmed that they are now using the new southstokepc.org e-mail address, and this now completes this process.
- **839** .Gov.UK Domain The Clerk is progressing the acquiring of a .Gov.UK Domain for the website and e-mails with support from Swan management Services (David Bewick). There is a £100 grant available, so the total cost of doing so will be just £5. Use of SouthStoke-PC.gov.uk is recommended best practice as it is far more secure and professional.
- **840** Noticeboard for Sulis Down Vistry have agreed to procure and install this to the agreed location in the Play Area.
- **841** Litter bins, Parish Litter and Sweeping in Sulis Down It is not thought possible to progress these matters at this point in time, both being the responsibility of the appointed Management Company

- **843** Village Green It was agreed, that on Receipt of a grant of £800 from the Village Fete Committee, the Parish Council would purchase two new Marquees at a cost of £1,141.67 (plus VAT) using the Parks and Open Spaces Budget for the £341.67 difference.
